Short answer

Biblical context is the information surrounding a passage that helps us understand what the biblical author intended to communicate. Context includes the surrounding words, the book's purpose, literary form, original audience, historical setting, covenant location, and place within the Bible's unfolding story.

Reading in context does not make the Bible less personal. It helps us apply God's Word faithfully because we first understand what it actually says.

Welcome

This companion was not written to replace your Bible. It was written to help you fall in love with it. Every page is intended to send you back into God's Word with greater confidence, deeper understanding, and a clearer picture of Jesus Christ.

The word context can sound academic, but the idea is simple. We already use context every day. If someone says, "That is just what I needed," we need the surrounding situation to know whether the person received encouragement, medicine, food, advice, or an answer to prayer.

Every verse belongs to a sentence. Every sentence belongs to a paragraph. Every paragraph belongs to a book. Every book belongs within the Bible's unified story of creation, rebellion, promise, redemption, mission, and restoration.

Foundational truth

The Bible is not merely a book to be understood. It is God's self-revelation, given so that people may know Him through Jesus Christ.

Purpose of this guide

- Understand the basic layers of biblical context.
- Read verses as parts of complete thoughts.
- Use historical and cultural information responsibly.
- Distinguish original meaning from faithful application.
- Recognize a passage's covenant setting and place in the whole Bible.

What Is Biblical Context?

Context is the setting that gives words their intended meaning. It helps us understand what is happening, who is speaking, who is being addressed, what came before and after, why the book was written, and how the passage fits within Scripture.

Beginner memory anchor

Before asking, "What does this mean to me?" ask, "What did God communicate through this passage?"

A simple example

Imagine receiving the message, "It is finished." Without context, it could mean a project is complete, a meal is ready, a relationship has ended, or a debt has been paid.

In John 19:30, Jesus says, "It is finished" while dying on the cross. John's Gospel shows that He is completing the saving mission the Father gave Him. His sacrificial work has reached its decisive fulfillment.

Good contextual reading holds three things together

- The original setting matters.
- The whole Bible matters.
- Jesus matters.



Rooted in Scripture - Pointing to Jesus

1. Immediate Context

Immediate context includes the sentences and paragraphs directly surrounding a passage. This is usually the best place to begin.

- What happened immediately before?
- What happens immediately after?
- Is this one sentence, paragraph, argument, story, or conversation?
- Are there connecting words such as therefore, but, because, so, then, or for?

Worked example: Philippians 4:13

"I can do all things through Christ who strengthens me" may sound like a promise that Christ will enable us to accomplish any goal we choose.

In Philippians 4:10-13, Paul explains that he has learned contentment when he has little and when he has plenty. Christ strengthens him to remain faithful through abundance and need.

What the verse means

Christ gives His people sustaining strength to remain faithful in every circumstance. The verse is not a promise of unlimited personal achievement.

Read the neighborhood

- Read the paragraph containing the verse.
- Read the paragraph before and after it.
- Continue across a chapter break if the thought continues.
- Look for the beginning and end of the author's complete thought.

2. Book Context

Every passage belongs to a particular biblical book. Book context asks who wrote it, who received it, why it was written, what situation it addresses, and what themes repeat.

Worked example: Jeremiah 29:11

This verse is often used as a promise that God will make an individual's immediate circumstances comfortable or successful.

Jeremiah was writing to Judean exiles in Babylon. God told them to build homes, plant gardens, raise families, seek the city's good, and prepare for a long stay. He promised that He had not abandoned His covenant people and would restore them at the appointed time.

What the context reveals

Jeremiah 29:11 reveals God's faithfulness and purpose in a long, painful season. It does not promise that every believer will avoid waiting, loss, or difficulty.

A beginner's way to discover book context

- Read the Bible edition's introduction as a human study aid.
- Read the first and final chapters.
- Notice repeated words and themes.
- Summarize the book's purpose in one sentence.

3. Literary Context

Literary context asks what kind of writing we are reading. The Bible contains narrative, Law, poetry, wisdom, prophecy, apocalyptic writing, Gospels, parables, letters, genealogies, and covenant passages.

We read a poem differently from a legal instruction, a parable differently from a historical report, and a proverb differently from an unconditional promise.

Worked example: Proverbs 22:6

Proverbs normally express wise observations about how life generally works under God's design. They are not always unconditional guarantees about every individual outcome.

Proverbs 22:6 teaches the lasting importance of faithful formation. It does not mean godly parents can control every choice their adult children make.

Memory anchor

Read each kind of biblical writing according to the way it was written.

Genre questions

- Is the author reporting what happened?
- Is this a command, poem, wisdom saying, vision, illustration, or letter?
- Does the writing use imagery, exaggeration, parallelism, or symbolism?
- What reading habits fit this form?

4. Historical and Cultural Context

Historical context includes the real people, places, rulers, nations, conflicts, and events connected to a passage. Cultural context includes customs, family structures, work, meals, worship, honor, shame, and daily practices familiar to the original audience.

The Good Samaritan

In Luke 10:25-37, a Samaritan helps a wounded Jewish traveler. The hostility between many Jews and Samaritans makes the choice of helper especially striking. Neighbor-love crosses the boundaries people create.

Jesus washes His disciples' feet

People traveled dusty roads in open sandals, and foot washing was a lowly act of hospitality. In John 13:1-17, Jesus deliberately takes the place of a servant and calls His followers to the same humble, self-giving posture.

Use background carefully

- Begin with what Scripture clearly says.
- Use trustworthy resources to clarify the setting.
- Distinguish established facts from possibilities.
- Do not make a passage depend on an unsupported cultural claim.

Two useful questions

What did this action communicate in its original culture? What lasting truth does the passage teach?

5. Covenant and Redemptive Context

The Bible's story unfolds through covenants, promises, commands, sacrifices, kings, priests, prophets, and acts of redemption.

Major covenant settings

- God's covenant with Noah.
- God's promises to Abraham.
- The Mosaic covenant with Israel.
- God's covenant with David.
- The new covenant fulfilled through Jesus.

A passage may address ancient Israel under the Mosaic covenant, a Davidic king, exiles awaiting restoration, Jesus' disciples, or a New Testament church. The passage remains God's Word, but its covenant setting helps us understand how it applies.

Example: Israel's sacrifices

Christians do not offer animal sacrifices because Jesus fulfilled what those sacrifices anticipated. Hebrews 9:11-14 and 10:1-14 present His sacrifice as once for all.

Leviticus still reveals God's holiness, the seriousness of sin, the need for atonement, and patterns fulfilled by Christ.

Memory anchor

Every passage is for our instruction, but not every command is addressed directly to us in the same covenant setting.

6. Whole-Bible Context

The Bible has many books but one unfolding story.

- Creation - God creates all things good.
- Rebellion - Humanity sins and the world is broken.
- Promise - God promises redemption and forms a covenant people.
- Redemption - Jesus fulfills God's promises through His life, death, and resurrection.
- Mission - The risen Jesus sends His people in the Holy Spirit's power.
- Restoration - Jesus will return, judge evil, raise the dead, and make all things new.

Worked example: the Passover lamb

Exodus 12 first belongs to Israel's deliverance from Egypt. Later Scripture describes the suffering servant as a lamb, calls Jesus the Lamb of God and our Passover, and presents the slain Lamb as victorious.

- Exodus 12:1-14
- Isaiah 53:4-7
- John 1:29
- 1 Corinthians 5:7
- 1 Peter 1:18-19
- Revelation 5:6-14

Guardrail

Whole-Bible context helps us see connections Scripture establishes. It does not give us permission to turn every small detail into a secret symbol.

How the Layers Work Together

Think of context as a house.

- Immediate context is the room where you are standing.
- Book context is the whole house.
- Historical and cultural context is the neighborhood and time period.
- Covenant context tells you where the house belongs in the family's history.
- Whole-Bible context shows how it fits within the entire community.

You need the room, but the room is not the entire house. You need the neighborhood, but assumptions about the neighborhood should never replace what you can actually see in the house.

A healthy order

- Begin with the biblical words.
- Follow the sentence and paragraph.
- Understand the book.
- Clarify the historical setting.
- Recognize the covenant location.
- Place it within the whole Bible.
- Apply the truth through Christ.

Who Is Speaking?

Not every statement recorded in the Bible is presented as true or approved by God. Scripture accurately records words spoken by God, faithful people, confused people, rebellious people, Satan, false accusers, and grieving sufferers.

Job's friends

Job's friends say many things about God and suffering. Some statements sound wise in isolation. Yet God tells them, "You have not spoken of me the thing that is right, as my servant Job has" (Job 42:7).

Context question

Who said this, and how does the passage evaluate the speaker's words?

Narrative description and biblical command

A story tells us what happened; it does not automatically command us to reproduce every action.

Example: casting lots

Acts 1:15-26 records the disciples casting lots to select Matthias before Pentecost. The passage does not command every church to choose leaders this way. Later passages emphasize prayer, wisdom, spiritual qualifications, and the Spirit's guidance.

Promises and Commands in Context

Promises have recipients

Some promises are universal. Others were given to a specific person, Israel as a nation, a Davidic king, a particular mission, or people within a covenant setting.

Joshua 1:9

God tells Joshua to be strong and courageous because he is leading Israel into the promised land. That assignment belonged to Joshua. The passage still reveals God's faithfulness toward those He calls, while Matthew 28:18-20 and Hebrews 13:5-6 assure believers of Christ's presence and God's help.

Commands have settings

- Who received the command?
- Is it tied to a covenant, office, or particular situation?
- Is it repeated in New Testament teaching?
- Does Jesus fulfill or transform its covenant expression?
- What lasting truth should believers obey?

"Do not judge"

Matthew 7:1 warns against hypocritical judgment, not all moral discernment. Jesus tells hearers to remove the beam from their own eye so they can see clearly, then warns them to recognize false prophets by their fruit. Read Matthew 7:1-20.



Rooted in Scripture - Pointing to Jesus

Five Commonly Isolated Passages

Matthew 18:20

"Where two or three are gathered" belongs to a passage about correction, witnesses, agreement, and church discipline. It does not mean Jesus is absent when one believer prays alone.

John 15:7

"Ask whatever you wish" is connected to abiding in Jesus, receiving His words, bearing fruit, and glorifying the Father. Abiding reshapes what believers desire and request.

1 Corinthians 10:13

This verse concerns temptation to sin. It should not be changed into "God will never allow more suffering than you can handle." In 2 Corinthians 1:8-10, Paul describes being burdened beyond his own strength so he would rely on God.

Psalm 105:15

"Touch not my anointed" recalls God's protection of the patriarchs. It should not shield modern leaders from biblical accountability.

Proverbs 29:18

"Where there is no vision" concerns rejecting God's revelation, not merely lacking organizational goals. Compare dependable translations.



Rooted in Scripture - Pointing to Jesus

From Meaning to Application

Context does not cancel personal application. Accurate understanding creates faithful application.

A healthy order

Observation: What does the passage say? Interpretation: What did the author communicate?

Application: How should this truth shape faith and life?

Four application questions

1. What did the passage communicate to its original audience?

Summarize the message in its setting.

2. What lasting truth does it reveal?

Look for truth about God, people, sin, redemption, worship, wisdom, mercy, justice, faith, and hope.

3. How does Jesus affect our understanding?

Ask whether He fulfills a promise, completes a pattern, establishes the new covenant, clarifies a command, accomplishes redemption, or embodies the truth perfectly.

4. How should we respond?

Response may include belief, repentance, obedience, worship, prayer, forgiveness, service, waiting, endurance, or trust.



Rooted in Scripture - Pointing to Jesus

Worked Example: Micah 6:8

Micah 6 presents a covenant dispute. God reminds His people of His faithfulness while they ask whether extravagant offerings can compensate for unfaithfulness.

Book and historical context

Micah confronts injustice, corrupt leadership, false worship, and covenant rebellion during a period of danger and spiritual decline.

Covenant context

God had already revealed His will. Ritual activity could not substitute for justice, mercy, and humble fellowship with Him.

Jesus and the whole Bible

Jesus perfectly embodies justice, mercy, humility, obedience, and covenant faithfulness. Through Him, believers are forgiven and transformed.

One possible faithful summary

Because God is faithful, just, and merciful, He calls His people to lives marked by justice, mercy, and humble fellowship with Him.

Application

- Am I using religious activity to hide disobedience?
- Where should I act justly?
- Do I love mercy or only want mercy for myself?
- Am I walking humbly with God?
- Am I depending on Jesus rather than trying to earn favor?

A Simple Process for Any Passage

- Pray for wisdom and a willing heart.
- Read the passage more than once.
- Read the complete paragraph before and after it.
- Identify the speaker and audience.
- Identify the kind of writing.
- Summarize the main point in one sentence.
- Consider the purpose of the book.
- Use historical and cultural information carefully.
- Place the passage within the Bible's story.
- Ask what it reveals about God, Jesus, people, sin, redemption, and faithful response.

A healthy order

Text first. Context second. Tools third. Response follows understanding.

Beginner checklist

- Have I read the whole paragraph?
- Do I know who is speaking and who is addressed?
- Have I identified the kind of writing?
- Am I treating a description as a command?
- Am I claiming a promise without its original setting?
- Does my interpretation fit the rest of Scripture?
- Does my application grow from the passage's actual message?



Rooted in Scripture - Pointing to Jesus

Common Context Mistakes

- Reading only one verse instead of the paragraph.
- Beginning with "What does this mean to me?"
- Ignoring the speaker or audience.
- Turning every story into a command.
- Using background information to override the text.
- Building doctrine on one unclear verse.
- Collecting verses by keyword without reading their settings.
- Assuming every promise is directly about me.
- Using context as an excuse to avoid obedience.
- Depending on a teacher instead of opening the Bible.

When you do not know

Faithful study does not require pretending. You can say, "The text clearly states," "The context strongly suggests," "One possibility is," or "The historical background remains uncertain."

Humility is not weak faith

God's Word is perfect while our understanding is still growing.

Use study tools in order

- Read Scripture.
- Observe the context.
- Write your initial summary.
- Compare cross-references.
- Consult a trusted resource.
- Return to Scripture.
- Revise if needed.
- Respond to God.

The Holy Spirit and Christian Community

Christians depend on the Holy Spirit to understand, receive, and obey God's Word. The Spirit who inspired Scripture does not lead us to meanings that contradict the Scripture He inspired.

- John 14:25-26
- John 16:12-15
- 1 Corinthians 2:10-16
- Ephesians 1:15-18
- 2 Peter 1:19-21

Context in community

God gives believers pastors, teachers, elders, and the wider church. Community helps us hear new questions, recognize assumptions, learn from Christians across history, and receive correction.

Healthy community welcomes verification

Be cautious when someone discourages questions, claims private revelation cannot be tested, uses isolated verses to demand control, treats disagreement as rebellion against God, or uses fear and secrecy.

A faithful goal

God's Word builds confidence in Him, not unhealthy dependence on a human leader.

The beginner section provides everything necessary to start. These pages introduce additional concepts that strengthen interpretation without requiring formal theological training or knowledge of Hebrew and Greek.

Intermediate memory anchor

Meaning is discovered through a passage's language, literary form, historical setting, book-level purpose, covenant location, and place within the whole canon.

Concentric circles of context

- Word - How is it used in this sentence?
- Sentence - What statement is being made?
- Paragraph - What complete thought surrounds it?
- Section - How does it function in the argument or story?
- Book - What is the author accomplishing?
- Historical setting - What situation prompted the writing?
- Covenant setting - Where is it in God's covenant dealings?
- Canonical context - How does the whole Bible develop the truth?

Working rule

Begin with the closest circle and move outward. Do not use a distant theme to erase the immediate message.

Authorial Intent and Fuller Significance

Interpretation seeks the communicative intention expressed through the biblical text. We pay attention to what the author wrote, how the argument develops, and what the original audience could reasonably understand.

Because Scripture is inspired by God, a passage can participate in a larger divine purpose that becomes clearer as revelation unfolds. Later Scripture may reveal fuller significance without denying the earlier meaning.

Hosea 11:1 and Matthew 2:15

Hosea 11:1 looks backward to Israel's exodus and introduces the nation's unfaithfulness. Matthew applies the verse to Jesus returning from Egypt.

Matthew presents Jesus as God's faithful Son who relives and fulfills Israel's story. The original meaning remains true, while the fuller pattern becomes visible through Jesus.

- Exodus 4:22-23
- Hosea 11:1-12
- Matthew 2:13-15
- Matthew 3:15-17
- Matthew 4:1-11

Words, Grammar, and Arguments

Semantic range

Words can have a range of possible meanings, but they do not carry every possible meaning in every occurrence. Context determines which meaning is active.

- Study how the word functions in the sentence.
- Compare the same author's usage.
- Consider similar passages.
- Choose the meaning that best fits grammar and argument.
- Do not pour every dictionary definition into one verse.

Connecting words

- Therefore points to a conclusion.
- For or because may give a reason.
- But introduces contrast.
- So that may show purpose or result.
- If introduces a condition.
- Then may show sequence or consequence.

Romans 12:1

“Therefore” connects Christian obedience to the mercies explained in Romans 1-11. The command to present our bodies to God is a response to grace, not an attempt to earn it.

Ephesians 2:8-10

Salvation is by grace through faith, not earned by works. Those saved by grace are then created in Christ for good works. The argument keeps grace and obedience in their proper order.

Historical Reconstruction and Cultural Claims

Three confidence levels

- High confidence - stated clearly in Scripture or strongly confirmed.
- Moderate confidence - fits available evidence but involves reconstruction.
- Tentative - possible but dependent on limited or disputed evidence.

Use language that matches the evidence

- The text states...
- The evidence strongly suggests...
- This may reflect...
- One possibility is...
- The precise background remains uncertain...

The eye of the needle

A popular explanation claims Jesus referred to a small city gate through which camels passed by kneeling. Reliable evidence for such a gate in Jesus' time is lacking.

In Matthew 19:16-26, the disciples understand Jesus to describe impossibility. Jesus answers, "With men this is impossible, but with God all things are possible." The context emphasizes God's saving power, not a difficult human technique.

How Scripture Uses Scripture

Kinds of connections

- Direct quotation - a later writer cites an earlier passage.
- Explicit fulfillment - the later text says an earlier passage is fulfilled.
- Established pattern - Scripture identifies an earlier person, event, or institution as a pattern.
- Allusion - distinctive earlier language is reused without a formal quotation.
- Echo or theme - a repeated image or idea contributes to a larger biblical pattern.

Guardrails

- Does the later writer establish the connection?
- Is the wording distinctive?
- Does the book's argument support it?
- Is the Old Testament context respected?
- Does it fit the Bible's larger story?
- Is the link probable or merely imaginative?

Promise, pattern, and fulfillment

A promise states what God will do. A pattern prepares readers for a later and greater reality. Fulfillment brings the promise or pattern toward its intended goal.

David's throne

Second Samuel 7 promises an enduring Davidic house. David's kingship provides a partial pattern. Luke 1:30-33 and Acts 2:29-36 identify Jesus as the promised King whose reign will never end.

Covenants in Greater Depth

Noah

God promises to preserve the world's regular order and never again destroy all flesh by a flood. Read Genesis 8:20-9:17.

Abraham

God promises descendants, land, blessing, and a mission through which all families will be blessed. Read Genesis 12:1-3; 15; 17; Galatians 3:6-29.

Moses

God forms Israel as a holy nation, gives covenant instruction, and establishes priesthood and sacrifice. Read Exodus 19-24 and Deuteronomy 28-30.

David

God promises an enduring royal line. Read 2 Samuel 7:8-16; Psalm 89; Luke 1:30-33.

The new covenant

God promises forgiveness, transformed hearts, knowledge of Him, and His Spirit. Read Jeremiah 31:31-34; Ezekiel 36:22-28; Luke 22:20; Hebrews 8:6-13.

Covenant questions

Who received this covenant instruction? What did it promise or require? How does later Scripture develop it? How does Jesus fulfill its redemptive purpose?



Rooted in Scripture - Pointing to Jesus

The Already and the Not Yet

Some promises have begun to be fulfilled but await completion. Jesus announced God's kingdom, defeated sin and death through the cross and resurrection, and sent the Holy Spirit. Yet suffering, temptation, death, injustice, and rebellion remain.

Already

Believers have forgiveness, reconciliation, adoption, the Holy Spirit, and eternal life in Christ.

Not yet

Believers await bodily resurrection, final judgment, the removal of death, and the renewed creation.

Worked example: death is defeated

Jesus has risen and broken death's dominion (Acts 2:22-36; Romans 6:8-11; 1 Corinthians 15:20-28). Believers still die while awaiting resurrection at His return (1 Corinthians 15:50-58; 1 Thessalonians 4:13-18; Revelation 21:1-5).

Why this matters

The framework keeps us from claiming every promise must be fully experienced now or postponing every present blessing until the future.

Tradition, Community, and Our Own Context

Every reader brings assumptions shaped by church tradition, culture, politics, suffering, education, and experience.

Theological traditions

Faithful Christians agree on central gospel truths while differing about some matters such as baptism, church government, spiritual gifts, covenant continuity, Israel and the church, and end-times details.

- Represent other positions fairly.
- Read the strongest biblical evidence.
- Distinguish central doctrine from secondary disagreement.
- State conclusions with appropriate humility.
- Remain anchored in what is clear.

Our own context

- What assumptions am I bringing?
- Am I reading my experience into the text?
- Is a teacher, culture, or political identity controlling the passage?
- Am I willing for Scripture to correct me?

The historic church

Christians should not read as though no one studied Scripture before us. Historical teaching can expose cultural blind spots and protect against old errors, while Scripture remains the final authority.

Christ-Centered Reading and Proof-Texting

Jesus teaches that the Scriptures testify about Him (Luke 24:25-27, 44-47; John 5:39-40). Christ-centered reading recognizes that the Bible's promises, covenants, sacrifices, priesthood, kingdom, exile, restoration, wisdom, and hope reach their center in Him.

Responsible Jesus connections

- Does the New Testament apply this passage to Jesus?
- Does He fulfill a stated promise?
- Does Scripture identify a pattern?
- Does the passage contribute to a theme fulfilled in Christ?
- Does it reveal the human need Jesus answers?
- Does it advance the redemptive story reaching its climax in Him?

Proof-texting

A short quotation is not automatically proof-texting. The problem is using a small portion to support a conclusion that ignores or contradicts its setting.

- Does the quotation represent the passage accurately?
- Does it fit the author's argument?
- Can the interpretation withstand reading the surrounding text?
- Does it agree with clear biblical teaching?

Difficult Passages and Confidence Levels

When a passage is difficult

- Read it repeatedly.
- Identify what is clear.
- Mark the exact point of uncertainty.
- Study immediate and book context.
- Compare dependable translations.
- Follow explicit biblical connections.
- Consult more than one trusted resource.
- Distinguish central truth from uncertain detail.
- Avoid hurried conclusions.
- Remain teachable.

Interpretive confidence

- High confidence - directly stated or strongly established.
- Moderate confidence - fits the evidence, though details may be discussed.
- Tentative - depends on indirect links or uncertain reconstruction.
- Speculative - lacks meaningful textual support.

Helpful language

Say “the passage teaches” for explicit truth, “the context strongly suggests” for a well-supported conclusion, and “one possibility is” for a tentative proposal.

One possible faithful summary

God remains sovereignly at work through every circumstance to accomplish His saving purpose of conforming His people to the image of His Son, and nothing can separate them from His love in Christ.

Why this matters

Romans 8:28 does not call evil good and does not promise that every loss will be explained during this life. It promises that suffering cannot defeat God's redemptive purpose for those who belong to Christ.

Final Encouragement

You do not need to become a scholar before you can understand the Bible. Begin with the text. Read slowly. Read the paragraph. Notice who is speaking. Identify the kind of writing. Learn why the book was written. Use background carefully. Follow the Bible's story. Look for Jesus where Scripture leads you to Him. Ask the Holy Spirit to shape your heart. Then respond faithfully.

Final memory anchor

Read the text. Respect the context. Recognize Jesus. Respond in faith.

A Call to Salvation

The purpose of Bible study is not merely to collect information. Scripture leads us to Jesus Christ.

All people have sinned and fall short of God's glory (Romans 3:23). Sin separates us from God, and we cannot rescue ourselves through good behavior, religious effort, or Bible knowledge.

The wages of sin is death, but God's gift is eternal life in Christ Jesus (Romans 6:23). Jesus, the Son of God, lived without sin, died for our sins, and rose bodily from the dead. While we were still sinners, Christ died for us (Romans 5:8).

Salvation is God's gift, received by grace through faith and not earned by works (Ephesians 2:8-10). Scripture calls us to repent, believe the gospel, confess Jesus as Lord, and trust that God raised Him from the dead.

If you are ready to turn to Jesus

Admit your sin, believe Jesus died and rose again, ask for forgiveness, place your trust in Him, and surrender to His loving authority. A prayer is not a magic formula; Jesus saves. Prayer is one way to express genuine repentance and faith.

A simple prayer

Lord Jesus, I know that I have sinned and cannot save myself. I believe You died for my sins and rose again. Please forgive me, make me new, and teach me to follow You. I place my trust in You. Amen.
